

REGISTRATION FORM FOR USE OF GOLF CARTS AT MARINA VILLAGE RESORT

Due to the actions of a few, we have had to increase the regulations on golf carts for the safety of all of our campers. We sincerely want to be able to allow those who are responsible users to continue to utilize these vehicles. A copy of these rules will be signed by the owner at the time of registration. Liability insurance will be required on all Golf Carts in use at Marina Village Resort (MVR). MVR is not responsible for any injuries or damages caused to personal property by a golf cart. The golf cart operator is solely responsible for these damages.

Prior to registration, each owner shall display their MVR Owner-Member # prominently, in large 3" letters on the rear of their cart. This will be your identification number for ease in registration.

REGISTRATION: All golf carts must be registered in order to use and enjoy in MVR. A registration fee, currently \$50, will be charged annually. Upon registration, all carts will be inspected for the MVR Owner-Member # and shall provide a copy of proof of liability insurance to be filed for emergencies. A registration sticker, bearing the year, will be issued by management and must be displayed in conjunction with the large Owner-Member # required for operation.

RULES:

- 1) All carts shall be battery operated only. **No gasoline powered carts shall be allowed.**
- 2) After dusk, carts may be used ONLY if the cart is fitted with proper headlights and rear red lights.
- 3) Carts may not be operated by unlicensed drivers. Driver's license must be carried during operation. Learner's Permits are not acceptable.
- 4) Carts may only carry the number of people they are designed for and all must be seated.
- 5) Operators MUST observe safe driving practices. Avoid excessive speed and unsafe maneuvers. (Speed limit on Resort property and in campground is 15 MPH.)
- 6) We ask that you be mindful and considerate of grassy areas and common areas. Please use roads and pathways whenever possible.
- 7) Please remember **DUI and public intoxication** is not a MVR rule, but **state law**. Driving a cart while intoxicated carries the same consequences as driving your car under the influence. Please drive carts responsibly and watch out for our children and pedestrians.

CONSEQUENCES OF VIOLATIONS OF THESE RULES:

1st Violation: Verbal warning

2nd Violation: \$50 fine

3rd Violation: \$100 fine and suspension of golf cart use for the registered year.

Failure to pay fines and follow suspension request can result in loss of all Resort use privileges.

Marina Village Resort does not in any way want to stop our campers from enjoying themselves. We feel that these rules and regulations are for your protection, both riders and non-riders. Please remember, there are people here that do not ride and the riders should not infringe on their rights. **Owners of Westwood Shores property will be required to follow the MVR registration process in order to use their golf carts in MVR.**

Marina Village Resort reserves the right to modify these rules at any time without notice.
