

OWNER-MEMBER POST PURCHASE QUESTIONNAIRE

Westwood Shores Marina Village Camping Club, Inc., dba Marina Village Resort, hereinafter referred to as "Club", is a private, member owned camping resort, in existence since August 1975, located on beautiful 90,000 acre Lake Livingston. The lake is excellent for all types of water sports including fishing for bass, crappie, bream and catfish.

TO: ALL NEW CLUB OWNER-MEMBERS

The following questions have been posed in an effort to insure that you, our Owner-Members, are fully aware of several important facts about the membership that you have purchased in the Club.

1. Did you receive, read and understand the Club Rules and Regulations?

2. Do you understand that your Owner-Membership in the Club is dependent upon your payment of the monthly assessments as they come due? If you fail to pay your assessment when due or violate the Club's Rules and Regulations, your privileges at the Club may be suspended or cancelled.

Also available through a reciprocal use agreement with neighboring Westwood Shores is an 18-hole golf course, tennis courts, inland lakes, Country Store and Marina, laundry room.

STATEMENT: As an Owner-Member in good standing of the Club, you are eligible to become a member of Camp Coast to Coast for a fee of \$995.00. If you elect to do so, your dues for one year to CCC will also be due at that time. Camp Coast to Coast will bill you directly for future annual dues, which are currently \$99.95 per year. You may use the camping areas of Camp Coast to Coast member camps by reservation on a space available basis. Currently total cost is One Thousand Points per night, equaling \$10.00 per night. Coast locations require advance reservations.

6. Do you acknowledge that no representations concerning possible future appreciation in the value of your Owner-Membership and that you are placing no reliance on any possible appreciation and that you are purchasing this Owner-Membership for use by your family and you, and not for commercial usage?

7. Do you understand that at this time you may use the 18 hole Golf Course at Westwood Shores Country Club, and if you desire to play golf, you may do so on a space available basis, by paying the current guest green fee?

ASSOCIATION AND RELATED PARTIES HAVE MADE NO REPRESENTATIONS OR WARRANTIES NOR HAS ANY UNIT OWNER OR LESSEE ON BEHALF OF THEMSELVES AND THEIR GUESTS OR INVITEES RELIED UPON ANY REPRESENTATIONS OR WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE, RELATIVE TO ANY FIRE PROTECTION, BURGLAR ALARM SYSTEMS, ACCESS CONTROL SYSTEMS, PATROL SERVICES, SURVEILLANCE EQUIPMENT, MONITORING DEVICES, OR OTHER SECURITY SYSTEMS RECOMMENDED OR INSTALLED OR ANY SECURITY MEASURES UNDERTAKEN WITHIN THE PROPERTY.
